Scoil Mhuire Gan Smál – Solar Panels Raffle TERMS AND CONDITIONS

1. THE SCHOOL

The raffle is being run to raise funds for Scoil Mhuire Gan Smál Primary School, located in New Inn, Cashel, Co. Tipperary. The promoter of the draw is the school's Board of Management and Parents Association who will organise and oversee the draw, ensuring transparency, fairness, and adherence to all relevant regulations.

2. AUTHORISATION

The draw is fully licensed under Section 28 of the Gaming and Lotteries Act 1956 (as substituted by Section 12 of the Gaming and Lotteries (Amendment) Act 2019). The raffle was granted a licence on May 2nd 2024 at Cashel District Court. The promoters will maintain compliance with all licensing requirements and applicable laws.

3. PURPOSE

The primary objective of the draw is to raise funds for the development and improvement of Scoil Mhuire Gan Smál school resources and facilities. The draw promoters will not derive any personal profit from the draw. All proceeds will be allocated to the school's development projects for the benefit of its students.

4. ELIGIBILITY

- Only individuals who have purchased an online raffle ticket via the I donate fundraising platform are eligible to participate in the draw. The draw is open to anyone across Ireland, provided they are persons aged 18 years or older.
- Any raffle tickets purchased by persons under the age of 18 years shall be declared null and void and shall not be included nor deemed to be included in the draw. Any such ticket entered in the draw will be declared invalid, and another raffle ticket will be drawn in its place.
- The draw promoters reserve the right to request proof of age and identity of the participants to ensure compliance with eligibility requirements.

5. THE PRIZE

- The prize in the draw is a full 3.5kw photovoltaic system. This will include photovoltaic installation, 8 panels tier 1, inverter and all accessories for installation.
- There is no substitute for the prize and a cash alternative will NOT be offered.

6. TICKET DETAILS

- The cost of a raffle ticket for the draw is €10 for one ticket, €25 for three tickets, €50 for 8 tickets and €100 for 20 tickets.
- Once purchased, the raffle ticket is non-refundable except in circumstances where the raffle is cancelled by the promoter.

7. CONDUCT OF THE DRAW

- The draw will take place on Friday 14th June 2024 in Scoil Mhuire Gan Smál school grounds.
- The school will appoint an independent observer who will oversee the conduct of the draw, ensuring fairness, transparency, and compliance with all relevant regulations.

8. PRIZE WINNER

- The winner of the prize in the draw will be notified by phone or email within 24 hours of the draw date.
- To claim the prize, the prize winner and Mitrossolar will make contact directly. The promoters of the draw will arrange for the prize winner and the company to have all relevant contact details to facilitate the meeting.
- Once the draw is completed, the contract for the prize fulfilment transfers to Mitrossolar and the prize winner. The promoters shall have no further liability to the prize winner.

- The promoter accepts no responsibility to the winner for any dissatisfaction with the prize.
- The promoter's decision in respect of the prize winner and all or any other matters concerned with the draw is final.

10. CANCELLATION

- The promoter reserves the right to cancel the draw for any reason whatsoever, including circumstances beyond its control.
- The cancellation or any amendment to the draw or these terms and conditions of purchase will be notified to the ticket purchaser as soon as practicable by publishing a notice in this regard via social media channels and the ticket sale online platform.
- In the event of cancellation, the promoters will refund the purchase price of the tickets.
